President's Report

At the February HOA Meeting, the Board voted to replace Elise Harmon with Dave Lemons as Board Liaison to the Operations Committee. (Please see the Contact List in this issue for liaison positions.)

HOA utility bills will be paid by direct debit from the HOA checking account. Additionally, after complaints by some residents, Verizon Wireless and Comcast Cable have been requested to inspect and to take action to repair or remove their respective utility boxes in Brightwater.

Students in Fort Bend ISD who live in Brightwater will continue to attend Lexington Creek Elementary, Dulles Middle and Dulles High schools for the foreseeable future. FBISD plans rezoning in small increments as new schools are opened. Stay informed.

2007 Financial Summary

The Brightwater HOA operates with a budget of just over \$510,000. We finished up 2007 with a surplus of \$35,000 which was moved to our Non-Capital Reserve Fund. We have a solid balance in our Capital Reserve Fund (used to replace/repair our major assets) and we earned interest in excess of \$50,000 on our CDs and other investments.

Projects funded outside of the '07 budget were tennis court repairs (\$14,830) and new landscape beds and trees (\$81,847). Considering past

expenses and the strong viability of our reserve funds, the Board was able to maintain annual fees at \$575, a level which is one of the lowest of the area's competing neighborhoods.

Security Report

A resident on **Clearwater Court** reported their SUV was burglarized February 21 while parked in the driveway. An Xbox and four controllers were stolen.

Two cars on **Northshore** were spray painted the night of March 16, after midnight. The investigating police officers commented that similar incidents of mischief have occurred on Northshore to cars parked on the street.

A resident on **Lakeside Meadow** reported that his vehicle tire was slashed the night of March 17. The incident was reported to the Missouri City Police Department and a case number was assigned.

Residents are strongly urged to park their vehicles in the driveway or garage to minimize chances of being the target of a crime!

Operations Committee

First Quarter Accomplishments

We've had a very productive period despite all the rain. Much of the work has been routine maintenance and will not be reported here, but below are some of the highlights.

- Three areas of with major standing water have been addressed: at the Clubhouse, Lakeside Meadow Park and Breezeway Park. Some of these repairs are still being finished. Once the ground settles at Lakeside Meadow, the new sidewalk will be poured and the turf replaced.
- The stucco walls on common property have been cleaned!
- The stamped concrete at the Clubhouse entrance has been repaired and re-stained.
- Two unstable and rickety benches were replaced.
- The concrete surfaces around the pool and the blue awning next to the baby pool were cleaned.
- New flags and new lights at the Clubhouse were purchased and installed.
- Signs referencing the city ordinance requiring owners to remove pet refuse were installed along the greenbelt.

Did you notice that we “topped” the trees in front of the Clubhouse? Those trees are older than the others and some large branches were splitting. The topping process can extend their life by as much as five years. It may look odd now, but we have done this before with good results. Watch them grow this spring!

Planned

- Spring landscaping
- Repairing a leak in the Clubhouse roof/ceiling
- Refurbishing and re-hanging the Clubhouse front door.
- Starting on stucco wall and tile repairs
- Preparing for pool opening with some new furniture and amenities

Because of conflicting obligations, **Dee Kappel** will have to resign in late April as Landscape Team Lead. She has done an outstanding job and will be sorely missed. Fortunately, **Mitch Roberts** has graciously volunteered to try his hand at replacing her. Dee will work with Mitch and show him the ropes for a while yet. Please join us in thanking him for volunteering his time on the Operations Committee.

Architectural Control Committee (ACC)

The Architectural Control Committee works to ensure that residential improvements comply with the neighborhood’s deed restrictions and guidelines. If you plan a spring project (exterior painting, deck or patio, new windows, roofing, etc.), we have included an ACC Application in this newsletter for your use. Please complete it and make sure you have all required attachments before submitting it to Crest Management. Once received, Crest checks that the application is complete and forwards it to the Committee for review. Residents should receive an approval or denial (with explanation) of their application within thirty days of the ACC receiving it.

Now is a great time to make those home improvements you been wanting! Fill in the ACC application and ensure that your project (and investment) complies with Brightwater covenants.

What's Happening?

Clubhouse Rentals: The Clubhouse rental fee is \$150, with a \$500 deposit fee. The Clubhouse holds 60 people, has a kitchen area with sink and refrigerator, various tables with chairs, restroom, telephone, parking and panoramic view of lake. Pool News: The pool season begins **May 3**. Pool tag distribution dates and times are printed on the **2008 Pool Schedule insert** in this newsletter. A resident must be current on annual maintenance fees and not have a deed violation in order to receive a pool tag.

Holiday Flag Service: Brightwater residents once again can register for Holiday Flag Service offered by **Boy Scout Troop 1294**. The cost will remain \$30.00 for the four holidays: Memorial Day, Flag Day, Independence Day and Labor Day and the troop will be available **April 5 and 19** at the Clubhouse during pool tag distribution for sign-up. Spring Clean-up: Once a month, Crest Management staff drives through our neighborhood to review properties and note any deed restriction/ACC violations. Some of the more common problems cited are: (a) **mildew** on the house, (b) **weedy landscape** beds or those that have visible landscape cloth (little or no mulch) and (c) **tree branches** overhanging sidewalks and streets.

We had a number of warm weeks this past winter and while weeds prospered, most lawn care duties were on hold. However, spring is in the air and it's time to tidy up your property. Your neighbors will appreciate it and you will avoid those pesky ACC violation letters. If you are planning to be away or otherwise cannot comply in a timely manner, please contact Crest so they can note the delay. **NOTE:** Residents with stucco columns on their property (along Brightwater Drive and Cartwright) are responsible for keeping those clean and maintained as well.

Garbage Update: Brightwater residents have been served by Allied/BFI Waste Management since 1991. Allied notified the HOA several months ago that the contract needed to be renewed and subsequently submitted a proposal for consideration. MUD #42, which encompasses Brightwater and four other residential developments, is also looking into the possibility of contracting garbage collection for its customers. All entities are working to provide residents with the best service at a good value. While this issue is being decided, Allied has agreed to invoice Brightwater residents for the second quarter. **Once a contractor has been selected, homeowners will be notified by letter.**

Tennis Court Use: In the past several months, a few residents have used the Brightwater courts for tennis lessons. While we encourage our homeowners to use our amenities, we want to be fair to all. Therefore, the HOA has agreed to the following **rules for private tennis lessons:**

1. Private tennis lessons are allowed only to residents of Brightwater and no more than six students per court.
2. Residents are responsible for and must supervise their children under 10 years old during instruction.
3. Only residents can reserve a court for instruction and have no preference over those signing up for general play.
4. Lessons must be concluded by 6:30 PM.
5. Residents assume responsibility for hiring licensed, insured tennis instructors.
6. Instructors are on property at the invitation of the resident and must abide by all court rules.

TENNIS COURT REMINDER

- ❖ When signing in, please use your full name.
- ❖ Please limit play to 1-1/2 hours no more than 3 days per week (no consecutive days). We have a lot of residents that would like to play tennis, but do not get the opportunity to do so.
- ❖ If your entire party is not present within 10 minutes of your sign up time and someone else is waiting, you will automatically forfeit your playing time.
- ❖ Please be considerate of your fellow tennis players and do not abuse your use of the tennis courts.
- ❖ Please take care of the sign-in cabinet. Thank you!

2. Resident must be current on annual maintenance fees and not have a deed restriction violation. Fee payment will not be accepted at pool tag registration.
3. Resident must have swim tag at all times while at the pool.
4. Rules are posted at the pool and will be strictly enforced. Anyone breaking the rules is subject to ejection from the pool.
5. If you are unable to attend the official registration days, tags will be issued by Crest Management by mail only. **There will be a \$20.00 per family fee plus postage for tags issued after May 3.**
6. Pool parties can only be held after pool hours. Contact Diane Giltner at 281 499-0695.

NOTE: The Pool is closed Mondays. If the pool is open on a holiday Monday, it will be closed on Tuesday for cleaning.

Please do not drop off small children by themselves. Children ages 10 and under will not be allowed in the pool area if they are not accompanied by someone 16 years or older.
